Teacher recruitment and deployment are the sub-components of component one stated as 'Quality' of PEDP4 (1st Revised). The objective of sub-component 1.3 is to ensure that teachers are recruited in required number and rationally deployed. To address and evaluate the accomplishment of the above sub-components, Disbursement Linked Indicator (DLI) target 2.2 (75% of the end of program target has been achieved as per assistant teacher (AT) recruitment plan) is fixed up as one of the indicators.

DLI Target 2.2:

75% of the end of program target has been achieved as per assistant teacher (AT) recruitment plan

Definition of DLI 2.2:

The teacher recruitment plan for assistant teachers refers to the Plan developed in Year 1, which provides the recruitment strategy and process, and the number of assistant teachers targeted to be recruited each year during the PEDP4 period.

Achievement Description:

This target is considered achieved when 75% of the total number of assistant teachers, targeted to be recruited during the program period as per the teacher recruitment plan, have been recruited.

Source of verification:

The evidence to be submitted: a) DPE consolidated report on assistant teacher recruitment and b) appointment letter of recruited teachers.
